Today i.e. 25/12/2024 at 6.32 am received a reliable information that on the same day at about 6.30 am exchange of fire between miscreants of valley and hill happened at the hill range of Mark hill (between midhill and hilltop) near Sinam Kom under Sagolmang Police Station. Police teams of Sagolmang PS led by OC Sagolmang PS, Adl SP (Ops)/ IE, 3(three) columns of 28 AR and one platoon of G/169 Bn. CRPF under the supervision of SP / IE rushed to the areas viz. Sinam, Ishikha, Ishingthembi , Kongba Maru to control the situation from all sides. The combined team repelled the miscreants at about 04.00 pm. At about 04.20 pm, one pompy was fired from the Markhill top and exploded on the midhill of Sinam Kom following few rounds of automatic weapon from the hilltop of Mark hill station. The firing was controlled by Security forces. No casualty and damage is reported.
