Sir,

As endorsed by the then officer in-charge, Yalngangpokpi police station. I have conducted an oral discreet enquiry into the written complaint report lodged by Lelvon Thangso (74 yrs) s/o late Leivon Thangkok Chief of Laikot Kom village, Kangpokpi District, Manipur with OC/YPI-PS on 6/8/2024 at 04:32pm as to ascertain the truth or otherwise of the allegations levelled against the conniver /accused person namely Paominlen Haokip of L. Chajang village, Saikhul sub-division, Sadar Hills, Kangpokpi District, Manipur (Committee on Protection of Tribal Areas Manipur (Kuki Hills) for his appeal to the NCST regarding the creation of separate tribal Kuki Hills(Kuki Land) State or Union Territory with legislature.

During enquiry, i have tried to contact the above complainant by visiting to his village but he was out of station at the said time. Finally, with the help from his younger brother namely Akhup through his mobile number 8414994530 I was able to contact the complainant and further informed him to give his statement at his convenient place and time. He willingly agreed to give his complainant statement at his residence at Laikot Kom village. On 16/08/2024 examined and recorded his statement by observing legal formalities. In which he stated that he and his villager came to known that one person namely Paominlen Haokip had submitted on 27/01/2024 a.fake, false narrative to some concerned court and other office seeking for separate administration from Manipur government and in that the Kom community residing in the Laikot Kom village also endorsed/agreed to his submission. Mr Paominlen Haokip's appeal to the chairman of National Commission for Scheduled Tribes covered Laikot Kom village in his Kuki Hills boundary and as Kuki. He further state that his submission is totally false, baseless and fabricated report submitted by him in connivance with some vested organization in order to create misunderstanding between Kom community and other community. He personally could not submit his complaint report to Yaingangpokpi police station on 06/08/2024 but entrusted the executive of Federation of Haomee as he was engaged in some other work. He further requested to convert the preliminary enquiry into a regular FIR and take legal action against the conniver as per law of the land in the interest of justice.

It is, therefore, submitted for your kind perusal and taking necessary action as an offence has been committed by the conniver namely Paominlen Haokip by making a false property mark, promoting enmity between different groups on the grounds of race, place of birth, etc., and acts prejudicial to maintenance of harmony.
