Today i.e. 22nd Sept.2024 at 11. 35 am received a reliable information that on the same day @ 11:30 pm some unknown armed Kuki miscreants fired some rounds using automatic fired arms to the Meitei community Yaingangpokpi Shantikhongbal village and Thamnapokpi village from hill top of Twichin and Thamnapokpi Uyok Ching with an intention to cause death, injuries, damage and destruction of properties. In which, Self OC/YPI-PS along with a combined team of Yaingangpokpi Police Station, Special CDO, Police/Manipur Rifle deployed at Thamnapokpi, Shantikhongbal retaliated several rounds towards miscreants. The intermitted firing ended at around 11.45 pm. The said situation was put under control and prevented the incident from further escalation.
