The OC/YPI-PS along with police team rushed to the said locations as there was inconvenient and intermittent firing continued till 11.50 pm of 09/11/2024. In which, a combined team of Yaingangpokpi Police Station, E/119 Bn BSF, Special CDO, CDO-IE, Imphal East District Police, Manipur Rifle deployed at Sabungkhok Khunou, Gectanjali Brick Field, Thamnapokpi, Shantikhongbal retaliated several rounds towards miscreants.
