Today i.e. 10/11/2024 at 09:45 AM received a reliable information that on the same day at @ 09.40 AM some unknown armed Kuki miscreants fired bombs and several rounds by using automatic weapons from hill top of Thamnapokpi Uyok Ching to the Meltel community of Thamnapokpi and Sanasabi villager while harvesting paddy at the paddy field located at Thamnapokpi and Sanasabi. Resulting in exchange of firing in between the armed Kuki miscreants and a combined team of Yaingangpokpi Police Station, Oscar 58, Special CDO, CDO-IE, Imphal East District Police, E/119 Bn. BSF, Manipur Rifle deployed at Sabungkhok Khunou, Geetanjali Brick Field, Thamnapokpi, Shantikhongbal and 4th Mahar Regiment retaliated several rounds towards miscreants. The OC/YPI-PS along with Yaingangpokpi police team rushed to the said locations and rescued all the farmers from many locations tactfully from the paddy field in spite of firing from both sides. The intermittent firing continued till 11:40 pm of 10/11/2024 and the situation was put under control and prevented the incident from further escalation.
