Subject: Lodging of FIR

Sir,

With due respect, I, the undersigned would like to state that the following few lines for kind attention and necessary action.

That on, 9<sup>th</sup> of May, 2024, I along with my family members had left our owned house occupying 5(five) rooms, 2(two) bathrooms having ground floor and G+1 owned by co-pattadar namely Anem Haokip and Lelein Haokip, house no.22, bearing Plot No. of Land under direct possession – 2342, and New Patta No. 207, at New Lambulane 3<sup>rd</sup> Street, Nongpok Ingkhol (B) in Ward no.22 of Imphal Municipal Corporation under the jurisdiction of Porompat Police Station for the safety of our life due to the prevailing bloody ethnic clash between the Kuki and the Meitei/Meetei communities. We were evacuated to Army Transit Camp, Minuthong Hatta on 9<sup>th</sup> May 2023. I along with my family member reached Kangpokpi Dist, and presently took shelter as displaced person staying in rented house at Kangpokpi Ward No. 17. Ever since 9<sup>th</sup> May, 2023 onwards, I could not learn about my thing that were left and I could not make complaint to the Police Station.

However, on 20<sup>th</sup> of May, 2024 at around 1:00 Pm, I was informed by reliable source that on 18<sup>th</sup> May, 2024, some unknown Valley Based miscreants had trespassed into my house, damaged, looted and stolen my properties which includes electronic items, important documents (like certificates, bond papers, etc.),etc. which are worth estimated to be around Rs. 22, 74, 000/- (Twenty Two Lakhs Seventy Four Thousand) only.

I, therefore, requested you to kindly look into the matter and take up necessary legal action as per the law of the land.


