Sir,

I the undersigned with due respect hereby lodge this Zero FIR that my movable and immovable properties at New Lambulane 2<sup>nd</sup> Street , PS Porompat Imphal East District, Manipur have been abandoned by me and my family members for fear of our lives due to the ongoing ethnic violence in Manipur and we fled/evacuated to Churahchandpur District for our safety on 9<sup>th</sup> & 17<sup>th</sup> May 2023 by the convoy of the Indian Army and my valuable properties in my house were safe and intact for several months till recently after we left Imphal.

However, it is learnt from reliable sources that most of my valuable properties have been looted/vandalized/damaged etc. on 12/7/2024 after we left our residential plot at Imphal under patta/Jamabandi No. 26(A)/411 duly issued by Directorate of Settlement and land records govt. of Manipur .

It is therefor, requested to kindly to take further necessary action as per law accordingly.

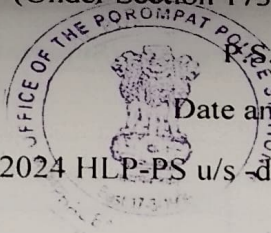
