The said person sending whatsapp message along with my photograph from his whatsapp No. 7085377602 by saying that " Nangna ei thibaga eina nang thibaga kana hena laigadaba mange" and warned to me within three days eibu moida Changjaraknaba akanba warning su pirakpa" after then again from the same sending me message that " Nang athubada ekhoida Changjarakoo nattrade chahi 20 henna yum thadoraklabani sirasu yarabaniko nang ama nupi angangda karan taba choppa ama mangkhiba haibse sana leibaki mangjaba natte matam ngairo. That, on 27/8/2024 he again call to me from the same mobile number and he demanded a sum of Rs. 1000000/- for their party fund.

It is, therefore, requested to kindly take up necessary legal action against the above mentioned accused persons.
