



Sir,

I have the honour to state that today i.e. the 11th of September 2024 at about 3:00 pm I along with my team of Sanjenthong Picket were on strict vigil at Southern side of Sanjenthong area in order to avoid any outward incident in connection with the agitation carried out by various student organizations. In that two persons coming from Mahabali side violating the curfew imposed by DM-IE vide order No. DM(IE)/5/4/2003(Pt-II) dtd. 10/09/2024 was detained for verification. On spot verification they identified themselves as Laishram Roshan Singh (26) S/o. L. Gulapi Singh of Khangabok Tangkha Leikai and Moirangthem Bumbum Singh (21) S/o. M. Deben Singh of Khangabok Meisnam Leikai. On conducting body search over them one live tear gas shell was found from the right side pant pocket of Moirangthem Bumbum Singh (21) S/o. M. Deben Singh of Khangabok Meisnam Leikai.


On spot examination of the two detainees they stated that they along with their associates took part in agitations at Thoubal and the said tear gas shell was taken to Imphal after their attack at SP-Thoubal Office to use it in the ongoing agitation at Imphal. They also further stated that they have been taking part in the ongoing agitation since some days back pelting stone by using catapults towards the Police personnel who are discharging their duties. Thus, the said tear gas shell was seized at 3:50 pm and the two detainees were arrested from the Southern side of Sanjenthong one after another at 4:00 pm and 4:05 pm respectively.


Therefore, the two arrested persons along with the seized item are handed over to Porompat PS for taking further legal necessary action as per laws.
