I have the honor to report that today i.e. 12/09/2024 at about 10:00 am, received reliable information that some persons were loitering near Sanjenthong Southern Side violating the curfew imposed by the DM/IE vide order No. DM(IE)/5/4/2023(Pt-II) dated 10/09/2024 with a view to commit prejudicial activities. Accordingly, I along with my team rushed at the said area. On reaching there, three persons were found loitering at the said place. Amongst them one person who later identified as Nikheel Arambam (17) S/o. A. Mangisana Sharma of Mayang Imphal Maibam Imphal West was found with a black pouch hanging on his neck. They were detained and verified. On verification, they identified themselves as (1) Nikheel Arambam (17) S/o. A. Mangisana Sharma of Mayang Imphal Maibam Imphal West (2) Mohd. Zaheer Ahamed (17) S/o Md. Zalil of Irong Chesaba Mayai leikai, Imphal West and (3) Mohamad Alfash Khan (18) S/o Md. Manowar of Phouden Yairipok Imphal East. Later, on searching inside the black pouch of Nikheel Arambam 1 (one) catapults is found containing inside the black pouch along with some pieces of iron rod from the possession of accused No. 1 (Nikhil).

On further verification, the 3(three) detainees admitted that they were involved in the ongoing agitation since someday back pelting stone by using catapults toward the police personnel while discharging their duties. Thus, the said catapults were seized at 10:20 am, and the accused no. 1 and 2 are apprehended at 10:24 am and 10:30 respectively thereafter the accused No. 3 is arrested at 10:35 am for further necessary formality.

It is, therefore, the 2(two) CCL and 1(one) individual were handed over along with the seized articles for taking further necessary action as per the law of the land.
