## 5. First Information Contents:

One shagolsem Inaocha Singh (37)yrs s/o (L) Shagolsem Birachandra Singh of checkon had reported that on 14/9/2024 @ 9:10 pm while he was returning to my home located at Checkon from Keirao on my two wheeler vehicle Jupiter Regd. MNOSC 2477 some unknowns persons around three persons in number had forcibly stopped him at the road side of Haionoubong , Kongba Laishram Leikai. They claimed themselves as members of Unit 34-Arambai Team of Heingang and then they had forcibly took him inside a four wheeler vehicle A-Star white in color ( regd. Unknown )and had Kidnapped him without telling me any reason ,they took him without telling the place they had taken, on seeing some local Meira paibe sitting near the road side at Mao market near 2Mr gate near Timber restaurant, I shouted and kicked the door of the vehicle and broke the door of the car and tried to escape by shouting to save him at the local Meiera peibi they had physical assault me trying to stop from escaping and one of them had taken out a short gun and point at me to stop shouting and had taken my Service ID of Indian Army because on hearing and seeing the physical assault all the local Meira Peibi rushed toward the spot . The Meira Peibi had stop them and they had save him from the incident. And they had fled away from the spot . Because of the physical assault he received major injuries on person on my leg, lips, my two left upper teeth had broken due to which he was evacuated at Dentex Clinic at Checkon . He could not report on time as I was hospitalized because of the injury.
