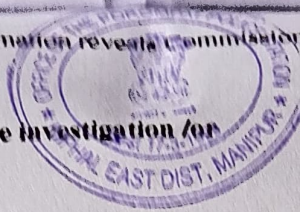




Today i.e. 05/10/2024 at 3:30 am it is found that one Facebook account titled "Hiyaikhomba News" uploading some words "MALEM THONGAM NA SARKAR DA THAKHIBA NUMIT 15 NI MATAM HAYENG SURAGANI, KARIGUMBA THABAKTA ONTHOKTRABADI SIBAGI KHONGJAM CHANGSHINNABA SEM SABA LOIRE. "Kuki MLAs 10 Khudakta Louthokadabani, SoO Agreement Thugairiba Kuki Lalhoukup Singh Terrorists ni haina Laothokkadabani Haibagi Demand Touraduna Transgender activist Malem Thongam na Sarkar da Thakhiba Numit 15 ni matam Hayeng Suragani haina Phongdokhre. Wafam Asi Ngasi Soibam Leikaida Leiba Citizen Clubs ta Paomi Singga Ounabada Phongdokhibani. Mahakna Makha Taraduna hai, karighumba Leingakta Thakhiba Matam Asigi Manungda Thabakta onthoktaba Tarabadi Chief Minister Bunglow Mamangda Masa Mathanta Sijaragani haina Laothokhiba Adu hayeng nungthil Pung 3.00 pm gi Matungda Khongjang Adu Mapham Matam Amada Hekta Pangthoknaba Sem Saba loire Haina Phongdokhiba Loinnana Changsingadouriba khongjang Asida Meeyamnasu Support Toubiu Hainasu Phongdokhre" which literally means Malem Thongam demanded that 10 Kuki MLAs should be removed, those Kuki militants who doesn't abide the SoO agreement much be declared as Terrorist banned organization. And if her demand is not fulfilled within the stipulated time Malem Thongam is set to commit suicide in front of the Chief Minister Bungalow.

Malem Thongam has been mobilizing people as well as organization against 10 Kuki-Zo MLA who are constitutionally elected members of Manipur Legislative Assembly. Her actions are aimed to divide people along communal line in extra judicial manner thereby amounting to incite criminal conspiracy, threatening against the Government of India and Manipur endangering Sovereignty, Unity and Integrity of India. Her words and actions promote enmity between different groups on the ground of religion, race, place of birth, residence language etc. She has also attempted to commit suicide to compel or restraint exercise of lawful power.

Hence a suo mottu case under FIR No. 499(10)/2024 PRT-PS u/s 196(a) & (b)/152/226/353(1) (b)&(c) BNS-2023 is registered for investigation.
