Today i.e. 05/12/2024 at 10:30 pm received a reliable information that on the same day at @ 10.26 pm some unknown armed Kuki miscreants fired two rounds using automatic fired arms to the Meitei community (Shantikhongbal village and Thamnapokpi village) from hill top of Yaingangpokpi Uyok Ching. Resulting in exchange of firing on both sides between the armed Kuki miscreants and villages volunteers (Shantikhongbal village and Thamnapokpi village). A police teams of Yaingangpokpi police station rushed to the said locations and intermittent firing continued till 11:50 pm of the same day. The additional forces led CO 4th Mahar Regiment arrived at the spot and the said situation was put under control and prevented the incident from further escalation by the security parties. In which, 4 Mahar Regiment, B-69 Bn BSF, Special CDO, CDO-IE, Imphal East District Police, Manipur Rifle deployed at the location of Sabungkhok Khunou, Thamnapokpi, Shantikhongbal retaliated several rounds towards armed Kuki miscreants.

In this regard the YPI-PS registered a Sou motto case under FIR. No. 51(12)2024 YPI-PS, U/S- 109/3(5) BNS. & 25(1-C) A. Act against the involved miscreants.
