Ibomeha a Taton a SK of KCP (PWG) group. They further stated that they were included in extortion description of the state general public, private firms, govt. offices, etc. and directly involved in the illegal arms smuggling. The detainees stated that, recently, on the advice of the said Mr. Ibomcha @ Taton @ SK of KCP (PWG), they had illegally purchase two nos. 303 fittes 1 along with magazines from one Mr. Yambung at the cost of Rs. 1, 25, 000/- (one lakh twenty five thousands rupees) and 1, 55. 000/- (one lakh fifty five thousand rupees) respectively. They detainees further revealed that, they are further planning/negotiating to buy another two more arms, of which one is SLR (Self loading Rifles) and the other is INSAS rifle. The detainees further stated that, today on the advice and instruction of the said Mr. Ibomeha @ Taton @ SK of KCP (PWG), they came to Khurai for buying arms from the said Mr. Yambung by the above recovered money which were handed over to them by the said Mr. Ibomeha Taton @ SK of KCP (PWG). So, the detainees were arrested from the office of Commando, Imphal East, Porompat at 4:46 p.m. by observing due formalities. One Sling bag containing a sum of Rs. 3, 50, 000/- (three lakh fifty thousand rupees), one wallet containing a sum of Rs. 17, 750/- (seventeen thousand seven hundred fifty rupees) and one AADHAR card and one mobile phone (Redmi 9) bearing. IMEI no. 865600050426916/ 865600050426924 along with two SIM cards having nos. Airtel - 8732820244 and Jio - 8837025392 were seized from the possession of the arrestee Athokpham (N) Irengbam (O) Inaobi Devi (à Nanao at 4: 48 p.m. by observing due formalities from the spot i.e. Office of Commando Imphal East District. Porompat. From the possession of the arrestee (Moirangthem Ichan Devi), a sum of Rs. 5, 200/- (five thousands two hundred rupees) and one mobile phone (Redmi Note 7 pro) bearing IMEI no. 861646040849638 and 861646040849646 along with one Airtel SIM having no. 6909911959 were seized at 4: 55 p.m. by observing due formalities from the spot ie. Office of Commando Imphal East District. Porompat. One mobile phone (Redmi A3) bearing IMEI no. 864259072721332 and 864259072721340 along with one Airtel SIM card having no. 8413966687 and one wallet containing a sum of Rs. 11.500/-(eleven thousand five hundred rupees), one AADHAR Card and one PAN card were seized from the possession of the arrestee (Oinam Abung Meitei) at 5:00 p.m. from the spot i.e. Office of Commando Imphal East District, Porompat. One car (Maruti A Star) bearing registration no. SK-04P/0096 bearing Chassis no. MA3EPDETS00161851 ENGINE No. K10BN1061610, one mobile phone (OPPO Reno 10xzoom) IMEI no. 864601040491276/ 864601040491267 along with one Airtel SIM eard having no. 7085692628 and sum of Rs. 3, 500/- (three thousand five hundred rupees) were seized from the possession of the arrestee (Yaikhom Lukhoi Singh) at 5:05 p.m. by observing due formalities from the spot i.e. Office of Commando Imphal-East District, Porompat. Jio - 6009746209 and Airtel - 8974344349 were seized from the possession of the arrestee Leimapokpam Hari Meetei at 5:15 p.m. by observing due formalities from the spot i.e. Office of Commando Imphal-East District, Porompat.

One ASL Sakir Ahamed Commando Imphal East Unit reported that today i.e. 22nd October, 2024 at about 3:00 p.m. received a specific information about the presence of some active members of the outfit KCP at Khurai. Imphal Fast District with an intent to commit prejudicial activities like extortion of money from the general public. Acting on the said input, teams of CDO Imphal East Unit led by myself under the command of Inspt. Kh. Henery Singh. OC-CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl SP(Ops)IE conducted a Cl. Ops. to the suspected passersby at Khurai Puthiba Leikai, Imphal East District. In that, six persons who came in one car and two scooters were detained for verification and spot checking. On verification, the driver of the ear identified himself as one: Yaikhom Lukhoi Singh @ Inao (32 years) S/o Y. Devan Singh of Pukhao Laipham Mayai Leiaki, Sagolmang PS, Imphal East District. The occupant of the car identified themselves as: (i) Athokpham (N) Irengbam (O) Inaobi Devi @ Nanao (38 years) W/o I. Romio of Wangoo Sandangkhong, Kumbi PS, Bishnupur District and Moirangthem Ichan Devi (20 years) D/o (L) M. Tomba Singh of Tangjeng Ahallup. Bishnupur District. On checking their belongings, a sum of Rs. 3, 500/- (three thousand five hundred rupees) and one mobile phone was found and recovered from the possession of the driver of the car Yaikhom Lukhoi. One Sling bag containing a sum of Rs. 3, 50, 000/-(three lakh fifty thousand rupees), one wallet containing a sum of Rs. 17, 750/- (seventeen thousand seven hundred fifty rupees) and one AADHAR card and one mobile phone were found and recovered from the possession of the occupant of the car (Athokpham (N) frengbam (O) Inaobi Devi @ Nanao). One mobile phone and a sum of Rs. 5, 200/- (five thousand two hundred rupees) were found and recovered from the possession occupant of the car (Moirangthem Ichan Devi). One of the scooter rider identified himself as one, Oinam Bijen Meitei (25 years) S/o O. Biren Meitei of Yairipok Khoirom Mathak Leikai, Yairipok PS. Thoubal District and the pillion rider identified himself as one Oinam Abung Meitei (31 years) S/o O. Chaoba Meitei of Yairipok Khoirom, Yairipok PS, Thoubal District. On checking their bodies, one mobile phone was found and recovered from the possession of the driver of the scooter (Bijen). One mobile phone and one wallet containing a sum of Rs. 11.500/- (eleven thousand five hundred rupees), one AADHAR Card and one PAN eard were found and recovered from the possession of the pillion rider (Oinam Abung Meitei). The second scooter rider identified himself as one, Leimapokpam Hari Meetei (53 years) S/o L. Budha Meetei of Kwak Shiphai Maning Leikai. Bishnupur PS, Bishnupur District. A/p - Pangei Lairam Mapal, Heingang PS, Imphal East District. On checking his body, one mobile phone and a sum of Rs. 1000/- (one thousands rupees) were found and recovered from his possession. While the detainees are trying to verified further, a large nos. of mob approached towards our CDO team and enquired why the detainees are being detained. The behaviour of the detainees seems very disturbing and perturbed and this attracted suspicion on them. Considering the situation and importance of further verification, our CDO personnel further detained the six detainees and bring them along with their belongings and the vehicles at the office of Commando, Imphal East District, Porompat, for further thorough verification. On reaching the office of CDO/IE Unit i.e. Porompat. Imphal East, further verification of the detainees were conducted. On further verification, the detainees stated that they are active members of the outfit KCP-PWG group and presently working under the command of one Mr.
