With reference to the above subject, I, the undersigned would like to inform you that upon routine inspection of bailey bridge and finished product Godown of Mechanical Division No- II, PWD, Manipur (Inside JNIMS Complex, Porompat) at 12:30 pm on 24th Oct, 2024, I found out that the wall of the north western corner of the Godown was partially damaged with the hole size of approximately 4 Sq feet (photographs enclosed) and many bailey bridge parts were missing. Most of the bailey parts kept which could be easily carried out through the hole were mostly stolen and upon further checking the numbers of missing bailey bridge items were assessed .



