As the matter got worsened, on 4<sup>th</sup> May 2023 out of compulsion I along with my family members fled from our house and took refuge in a safer place. Since then, I couldn't visit my house till date as the situation got from bad to worse.

Now, I am told from a reliable source on 25<sup>th</sup> May 2024 at around 01:00 PM that my 2-storey building house in New Lambulane, Imphal has been looted and illegally occupied by unknown person(s) taking the advantage of the current turmoil in the state.

And I also sincerely beg your pardon for late first information report as I have received the information very late.

Therefore, I humbly request your good self to kindly register my case for further investigation and necessary action as per the law of the land. I shall be much obliged for your kind consideration.
