Respected Sir,



Subject: Complaint against unknown person for trespass, encroachment upon my property and forceful dispossession thereof, mischief, theft, and for disobedience of an order of a public servant.

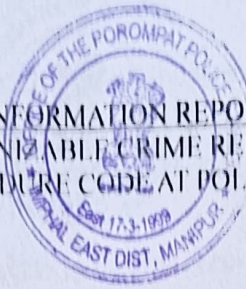
Sir/Madam,

I, David Haogoulain Haokip, aged about 36 years, s/o Letkhogin Haokip, owner of Dawllar Inn, 2nd street, Link Road 1, New Lambulane, House No.48 as per the electoral sheet would like to submit my grievances for kind consideration and redressal. I had fled my residence with all my family members on the 8th of May 2023 after the ethnic clashes broke out on the 3rd of May, 2023, for our own safety. My father, Shri. Letkhogin Haokip (Retd. I.A.S) who also lives with me in the same house had also submitted an application to the concerned authority to look after my possessions on the 12th of Feb, 2024(enclosed), when news of looting and dispossession had turned up. However, on the 11th of April, 2024, at about 4pm, I received information that my residence had been ransacked and looted and presently occupied by unknown Meetei miscreants. The building has 5 floors and the value of the belongings that was in the house amounts to 2 Crore rupees. Not only are these despicable acts punishable offences under the Indian Penal Code (IPC) but they also contravene the order dated 10th October, 2023 issued on behalf of the Governor by the Commissioner (Home), Govt. of Manipur. Notably, the violation of the said order is also a distinct offence punishable under section 188 of the IPC.

I, therefore request you to register an FIR for theft, illegal occupation and other related offences under the relevant sections of the IPC. For violation of the order stated above (10th October, 2023), offence under Section 188 of the IPC may also be incorporated. Therefore, the same may kindly be forwarded to the concerned authority (Porompat) at the earliest so that necessary action may be taken. I also request you, being in a position subordinate to the




