

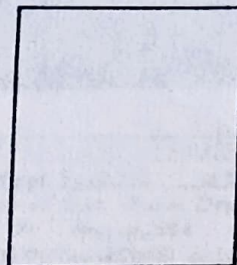

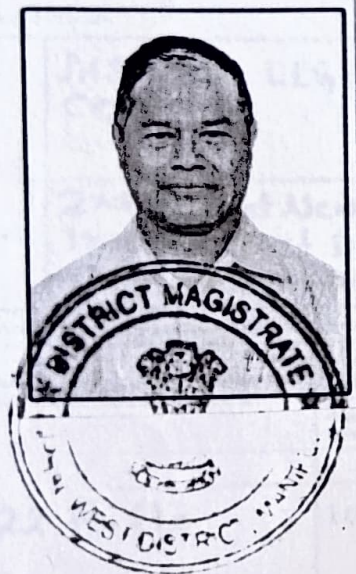

Subject: Report regarding the loss of my Czech Republic made .22 Brno Rifle (Imported) from my house at 2nd Street, New Lambulane, Imphal East District in the course of the mass looting carried out by unknown miscreants during the 1st week of February, 2024.

Sir,

I am to report that whereas my above house was looted by unscrupulous miscreants between the last week of January and the 2nd week of February this year (2024), in spite of the presence of para-military forces like the CRPF & other units (besides the Manipur State civil police) who were posted there to safeguard the abandoned properties due to the on-going Civil War, my imported & licenced Brno .22 rifle (made in the Czech Republic), having the following details, besides movable properties worth more than Rs.60 lakhs, have been stolen/taken from my said house. The following are the details of the stolen gun.

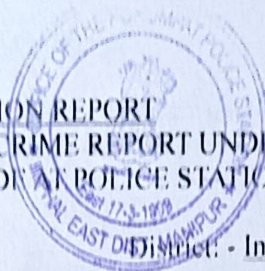


