Subject: Complaint/report regarding the looting/vandalisation of almost all the movable properties from inside my house located on "2<sup>nd</sup> Street, New Lambulane, Imphal East District, covered by pucca patta/Jamabandi no. 1448, Dag no. 5453/5715, 26(A), Nongpok Ingkhol, Imphal East, worth more than Rs.65 lakhs by unscrupulous local miscreants between the last week of January and the 1<sup>st</sup> week/2<sup>nd</sup> week of February, 2024.

Sir,

I have the honour to report that compelled by the on-going 'Civil War', which broke out on May 3, 2023, I and my family members had to leave my above house during the month of May, 2023 for reasons of our personal safety. In view of the tense situation at the time we could not take with ourselves all the valuable articles inside the house, except for a few clothings. Thanks to the posting of some paramilitary security forces inside New Lambulane locality all the houses in the locality (including my own house) were safe till the last week of January this year (2024). My house was also quite OK till January 27, 2024.

However, some unidentified and unscrupulous looters (locals) started looting my house thereafter, inter alia, between the last week of January and the 1<sup>st</sup> or 2<sup>nd</sup> week of February, 2024. The matter has been confirmed by my well wishers from the nearby localities. As per their reports the para-military forces/ security posted inside New Lambulane to safeguard the abandoned houses and properties inside, and the local civil police present at the time/scene, remained mute spectators of the looting and vandalism which took place right in front of their eyes. The tragic part is that whereas the (abandoned) houses and properties inside New Lambulane were taken care by the para-military security forces posted there and almost all the houses and properties were reportedly safe till the last week, or so, of January this year (2024) the looting and vandalization of the properties – both movable and immovable – took place between 28/01/2024 and mid-week of February, 2024. Hence, the State administration is responsible for what has happened there.

I also would like to make a mention that whereas at the instance of Shri James Kamel, Asst. Comdt. of 86<sup>th</sup> CRPF, a Platoon of CRPF were posted in my house from 28/10/2023 some Police personnel from Imphal East (in civil dress) reportedly drove them out from there (my house) on the morning of 31/10/2023. Our pleas to the present S.P. Imphal East, and even the Hon'ble Manipur Chief Minister, to allow the CRPF platoon to stay and continue guarding my house, fell on deaf ears. Hence, my house has been deliberately allowed to be looted and vandalized of its contents by the locals from Imphal valley, whereby properties worth more than Rs.65 lakhs, including ONE licenced .22 Bruno Rifle (imported - Czech Republic made) have been looted.

I am enclosing herewith photocopies of the Title-Deed/Patta – Jamabandi no. 1448, Dag no.5453/5715 (26 A – Nongpok Ingkhol, Imphal East District) of my plot of land admeasuring .092 acres), the details of the properties stolen and vandalized (worth Rs.65,70,390) in a separate annexure of 4 pages/sheets, and photos taken of my house before and after the 27<sup>th</sup> January, 2024 to substantiate the veracity of my report/daim and for your kindly doing the needful.


