Complaint against the loss of valuable possessions at my New Lambulane Residence, Link Road 1, 2<sup>nd</sup> street, House No.94 as per electoral sheet.

Sir/Madam,

I, Nengneivah Eva Haokip, aged about 38years, d/o Letkhogin Haokip, a permanent resident of New Lambulane, 2<sup>nd</sup> street, Link Road 1, House No.94 as per the electoral sheet would like to submit my grievances for kind consideration and redressal. I had fled my residence with all my family members on the 6<sup>th</sup> of May 2023 after the ethnic clashes broke out on the 3<sup>rd</sup> of May,2023, for our own safety. I had also submitted an application to the concerned authority to look after my possessions on the 12<sup>th</sup> of Feb, 2024(enclosed), when news of looting and dispossession had turned up. However, on the 11<sup>th</sup> of April, 2024, at about 4pm, I received information that my residence had been ransacked and looted. Some of my looted possessions are as followed:

1. Bed (2nos): Rs.104000+Rs.65000

2. Mattress(2nos): Rs.42000+Rs.20,000

3. Teak Cupboard: Rs. 125000

4. Dressing Table: Rs. 45000

5. Bedroom Chairs(2sets): Rs.150000+ Rs.45000

6. Washing Machine: Rs. 50,000

7. Dining Table and Chairs: Rs.55000

8. Gas, and other utensils: Rs.100000

9. Fridge: Rs.32000

10. Teak doors, windows, clothes, electrical appliances and other miscellaneous: Rs.400000

11. Cloth hanging wood: Rs.20000

12. Common Room table + side table: Rs.20000

Not only are these despicable acts punishable offences under the Indian Penal Code(IPC) but they also contravene the order dated 10<sup>th</sup> October, 2023 issued on behalf of the Governor by the Commissioner(Home), Govt. of Manipur. Notably, the violation of the said order is also a distinct offence punishable under section 188 of the IPC.
