Subject: First Information Report on the crimes of looting, vandalism and discrimination of Schedule Tribes.

Sir/Madam,

With reference to above cited subject, I have the honor to report to you as follows:

That, on the 6th of May 2023 at about 01:00 PM we escaped for our lives as we notice a huge contingent of armed radical Meiteis suspected to be "ARAMBAI TENGGOL and MEITEI LEEPUN" along with the local Meitei attacked New Lambulane, Imphal. We ran out to save ourselves to the safety place and reached Churachandpur in the Month of July 2023 leaving behind all our properties.

That, it may also be reported here that the above-mentioned Meitei looted our properties and incurred huge loss which is estimated to be around Rs. 37,60,600 (Thirty-seven lakhs sixty thousand and six hundred) only. That, after looted all the properties, the Meitei rented my house to some unknown people.

Further, my FIR is late because of the reason below:

1. I have been trying to submit the FIR at the police station but I was advised to first confirm whether my house and properties has been burned/destroyed.
2. Not only this, I am suffering from Cerebral Atrophy for longtime till today and could not pursue sooner.

That, In the given circumstance, I humbly pray you to kindly register a ZERO FIR, investigated the matter and punish the perpetrators as per the prevailing provisions of the laws of our Country. And, for which act of kindness, I shall always remain thankful to you and obliged.

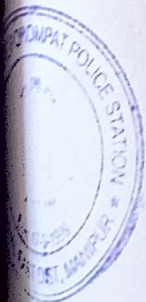

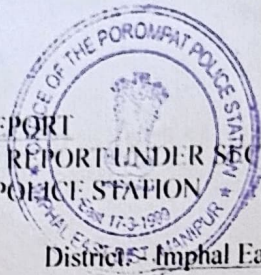


