



That I, along with my elder brother have been renting a house at chassad avenue, Dimlailong, Imphal as we were studying in Imphal. Due to the sudden communal violence, we escaped from the house in 4<sup>th</sup> May 2023 and we did not have time to take along with us any of our belongings including our important original documents (certificate). We have been hoping to avoid the change to get atleast our certificates (Documents) by any means. Unfortunately, we have not been able to avail the chance. Meanwhile, it is learnt from reliable source that our house had been vandalised and all belongings inside the house have been either looted or destroyed with my little chance of recovery.

I therefore request your goodself to kindly register and FIR in this regard for kind necessary action.
