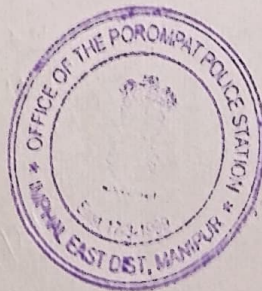

Sir,

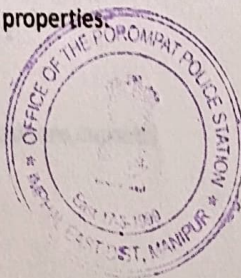
With due respect, this is to inform you that, due to the violence that broke out on the 3rd of May 2023, I the undersigned, and my family left our house, EL-Bethel Cottage on the 5th of May 2023 which is located in New Lambulane, 3rd street, Imphal East.

After more than a year, it has come to our understanding that some unknown miscreants have looted all our properties including furnitures, books, musical instruments, electronic items, clothing, utensils, etc. whichever is inside the house on the 17th of April 2024 at around 10 AM. The total estimated value of the properties is around 30 lakhs (excluding the landed property). It has also come to our senses that the unknown miscreants have occupied the house too.

The reason for the delay in filing this report is that we are out of station since May last year and also got the information recently through a reliable source. So, I would like you to kindly register my complaint and look into the matter as we desperately need police intervention.

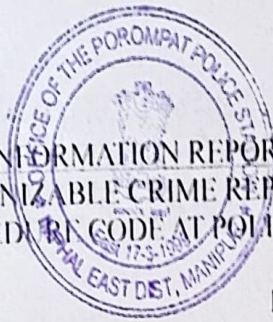
