U/s 74/79/356 Bhartiya Nyaya Sanhita 2023 as last option. However, I flatly denied the same as I did nothing with regard to the false charge aas leveled against me. In this regard I Pray that your kind and necessary action be taken against the persons involved as I have mentioned here in above for Justice and equity in future.
