With reference to the above-cited subject, I would like to state that I am a permanent resident of New Lambulane, PO/PS Porompat and the proprietor of Gen's Corner shop located at JV Shopping Mall, 3rd Street, New Lambulane, Imphal East, Manipur. I have been taking refuge in Churachandpur following the outbreak of communal violence in the state. Recently some miscreants openly looted residences in Newlambulane during which my shop Gen's Corner was also subjected to rampant looting of all items between 27/04/2024 to 30/04/2024. The total value of the clothes and furniture was estimated to be 25 lakhs approximately. The shop is now empty and the same has been verified by one of my acquaintances living in the locality.

It is therefore requested to kindly register a case and book the culprit as per the law.


