Subject: Report on vandalism and looting.

Respected Sir,

I, Mrs. Chinneikim Vaiphei, wife of (L) Ngamjatong Vaiphei, aged 62 yrs, had rented a house at **New Lambulane 2nd Street, Imphal East - 795001 under Porompat Police Station, Imphal East**. On the **3rd of May 2023**, while I was visiting relatives in National Games Village Zone-I in Imphal, the clash between the Meitei and Kuki community broke out. We were stuck in Imphal along with my relatives while the incidents took place. When the Meitei mob attacked us, we ran for our lives seeking shelter in CRPF Camp located in Lamphelpat (143 BN, CRPF). When we reached the camp we were shocked to see that 6000 people were already seeking shelter over there. There was barely any space for us. We were terrified and our minds could not be at peace. There was a news that some people were not lucky enough and the mob had tortured and killed them before they had reached the army camps. We were not even completely safe inside as the mob had attempted to attack the camp but luckily the army were able to protect us. On the **6th of May, 2023** around 10:00 AM while enquiring about our belongings, we came to learnt from our Naga neighbours that Meitei miscreants had looted all the valuable goods and destroyed the remaining.

It was a nightmare, there were no proper bed or shelter, we could only lie on the open ground. The food that they had provided was not sufficient for all of us see people had to sleep hungry. None of us could get proper sleep as the mob could attack us anytime. On the **9th May 2023**, with the help of the Para military were escorted to Imphal Airport and were able to reach Guwahati and then to Shillong safely.

After reaching Shillong, we couldn't return back to Manipur for some months due to financial reasons. So, I wasn't able to file the report on time, for which I beg your pardon.

Hence, we request you to do the needful in restoring the situation and book the culprits at the earliest possible time. I would like to be compensated for the losses as well.

Details of our losses have been attached with this letter.
