Sir,

With reference to the above stated subject, I the undersigned have the honour to state that I came to know in the last week of May 2024 that my private properties as details given below have been looted and destroyed by the unknown miscreants during the first week of May 2024.

**1. Looted properties includes:**

i) Electronic items such as one no. of Split AC, 1 no. of Sony Smart TV (65 inches), 1 no. of Printer, 1 no. of Refrigerator of 200 litres capacity, Kent RO System, 2 nos. of Washing Machine, Grinders, Oven, Induction etc. worth Rs **5,80,000/- (Five lakhs eighty thousand)** only.

ii) Furnitures such as 2 no. of VIP Sofa set, 1 no. of wooden Sofa set, 5 nos of Godrej Steel Almirah, 4 nos. of wooden Almirah, 1 (one) TV Stands, Dining Table with 6 chairs etc. worth Rs **7, 45,000/- (Seven lakhs forty five thousand)** only.

iii) Household items such as 5 nos. of King size beds, 5 nos. of Mattress, about 60 woolen blankets, 4 nos. of bed box, cushion, utensils, 4 nos of water tank(Syntax), garments belonging to our family, more than 100 nos. of traditional shawls etc. worth Rs **7,00,000/- (Seven lakhs)** only.

iv) Kitchen Items such as 1 no. of Gas Stove, 4 nos of Gas Cylinder etc. worth Rs **50,000/- (Fifty thousand)** only.

v) Altogether, properties worth Rs **20,75,000/- (Twenty lakhs seventy five thousand)** only has been looted and destroyed from my private rented residence at New Lambulane, 3<sup>rd</sup> Street, PS: Porompat, Imphal East.

**2. Date of occurrence is 1st week of May 2024.**

3. It is, therefore, requested to register FIR for kind further necessary action.



