Sir,

I have the honour to report that on 13/11/2024 at about 4:30 pm, one of my friend namely Mk. Kadir Khan aged about 50 years S/o not known of Khurai Helgru Makhong Bazar, Imphal East was informed and told by one unknown person namely Sanajaoba to do some task in his favour. Accordingly, Mk. Kadir calls (Mob. No. 6909719356) over my phone and told me to come at Babu Hotel at Lamlong Bazar pretended in assisting for his vehicle which broke down at Lamong Bazar. Accordingly, I came on my two wheeler vehicle Honda Activa without registration No. blue deep colour at the said places i.e., Babu Hotel, Lamlong Bazar, Ukhrul road. In that I was abducted before Mk. Kadir Khan and then I was blind folded, tightened both my hand and assaulted by the 4/5 unknown miscreants under gun point and forcefully dragged into one unknown car (grey). Thereafter I was taken to unknown places and demanded a sum of Rs. 1, 00000 (One Lakh) and also they kept my Honda Activa under their custody and never returned back.. On the same day 13/11/2024 at around 9:30pm I was released by the said unknown person at Kongpal Laikhulembi ground. The entire act is under the instigation of Mk. Kadir and Sanajaoba.

It is therefore requested to take appropriate legal action against the unknown persons according to law.


