12. First Information Contents:

Today i.e. 17/11/2024 at 2.20 am received an information that on 16/11/2024 from 8.45 pm, a large numbers of unruly mob/ agitators including male and female mostly youth numbering around 1000/2000 armed with deadly weapons like stick, stones, and petrol bomb swarmed towards the residence of Hon'ble Minister (CAF&PD and PHED) Khurai A C Shri. Leishangthem Sushildro Singh @ Yaimu located at Khurai Sajor Leikai Tinsid Road with a view to attacked the residence of Hon'ble Minister Leishangthem Sushildro Singh Khurai Assembly Constituency in connection with brutal killing of 6 (six) civilian including three children at Jiribam by Kuki Narys Terrorist on 11/11/2024. Police team who are deployed at the area informed to Police control room and immediately a strong Police team including SP-HE, Addl. SP (L&O) HE, SDPO-PRT, DSP-CDO&Ops HE, OC/Porompat PS, CDO and KI-41 with teams of Porompat Police Station and other Officers rushed to the said area. A clear warning was given to the mob on the violation of normalcy. The mob did not pay heed instead resorted to pelting of stone and attacked Police. Left with no option, permission was obtained from the magistrate present at the spot to disperse the unruly mob police resorted to mild lathi charge and fired tear gas shell and smoke Bomb. The unruly mob became furious and was very difficult to control rather uncontrollable. They managed to vandalized and set on fire the house of Hon'ble Minister Leishangthem Sushildro Singh. The unruly mob simultaneously attacked the house by pelting stones as well as fire arms from unknown direction. In that, wall glass and some properties were partly damaged in the attacked. That, the mob was dispersed at 10.10 am of 17/11/2024 with the arrival of additional force. In the violent attack some civilians including a security personal were received injury during mob control and they were evacuated to JNIMS and Shija Hospital Langol for medical treatment.

Hence a suo motto case under FIR No. 563(11)/2023 PRT-PS u/s 191(2)/191(3)/190/223/189(5)/132/324(4) BNS-2023 and 25(1-B)A. Act has been register for investigation

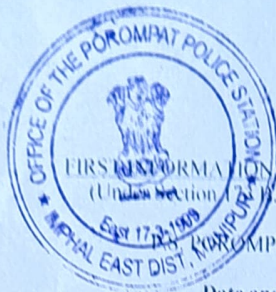
