I have the honour to report that today i.e. 23rd November, 2024 at about 3:00 p.m. received a specific information from 4 AR corroborated with our own intelligence about the presence of some anti-social elements at Khurai Ahongei area of Imphal East District, who were directly involved in the firing of a numbers of rounds (fire-arms) at the general area of Mantripukhri and its surrounding, threatening the general public and disturbing the normalcy of the present law and situation. Based on the said information, teams of CDO Imphal East Unit along with woman police personnel led by myself assisted by SI. S. Lolindro Singh of Imphal West District Police now attached with CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a mobile frisking and checking to the suspected passersby at Porompat near JNIMS main gate, Imphal East District.

In that, two suspected persons, one man and one woman, who seems to be very disturbed and perturbed were spotted going hurriedly along the Khurai Ahongei Leirak. On noticing their suspicious nature, our CDO personnel immediately followed the two unknown persons and detained for verification and checking at their residence. On verification, the detainees identified themselves as one, **Thoudam Ibungobi Meitei @ Taton (48 years) S/o (Late) Th. Ibomcha Meitei of Naharup Makhapat, Imphal East. A/p - Khurai Ahongei Labuk Leirak, Imphal East** and the woman identified herself as one **Chanam Rashni Chanu @ Tulshi (32 years) W/o - Th. Ibungobi Meitei of Naharup Makhapat, Imphal East. A/p - Khurai Ahongei Labuk Leirak, Imphal East**. On checking the detainee (Thoudam Ibungobi Meitei), one 9 mm Pistol loaded with fifteen live rounds, two nos. of live 9 mm ammunitions, one radio wireless set, one mobile phone were found and recovered. On further verification, the detainee (Thoudam Ibungobi Meitei) stated that he is an active member of the outfit UNLF (Pambei) group, joined in the year 2002 though one Mr. Dhananjoy of UNLF and got his basic military training in the year 2003 under army no. 1740 of 28th batched at Songpha Village, Churachandpur district, Manipur and presently holding the rank of s/s - Lieutenant working under the command of one s/s - Major Mr. Nongdon of UNLF (Pambei) group. The detainee further stated that he is directly involved in extortion of money from the general public, private firms, govt. offices etc. for raising their party fund.

In the above facts and circumstances for being illegal and unauthorised possession of arms and ammunitions, extortion of money from the general public, by the detainee (Thoudam Ibungobi Meitei) and for being accompanying the detainee, Thoudam Ibungobi Meitei, the other detainee (Chanam Rashni Chanu) were arrested from their residence i.e. Khurai Ahongei Labuk Leirak, Imphal East at 4:31 p.m. and seized; (i) one 9 mm Pistol marked as 'PIETRO BERETTA GARDONE V.T. - Made in Italy' loaded with 15 (fifteen) live rounds in the magazine, (ii) two nos. of live 9 mm ammunitions, (iii) One wireless radio set (STELE
