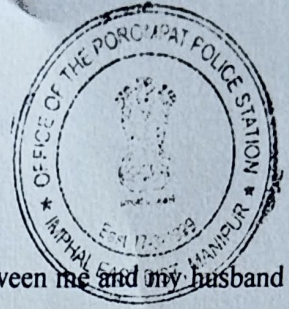


With due respect, I beg to report you that today, i.e. on 08/12/2024, at about 11:00 a.m., my husband, namely Sarangthem Santosh Singh, S/o (L) S. Deven Singh, aged about 39 years, of Kongpal Chanam Leikai, Imphal East District, Manipur along with his mother, namely Sarangthem Leibakleima Devi, his elder brother, namely Sarangthem Kalamu Singh and his sister-in-law, namely Sarangthem (O) Tamphal Devi had beaten me black and blue without any reason. My husband had kicked and punched me in my body and my mother-in-law even strangled me and slapped me using chappal and tried to throw tool (mora) towards me and while beating and torturing me, my husband was intoxicated with alcohol. Due to the beating, I was injured in my face, right eye, right ear, tenderness bridge of nose, bruise in left arm. I was rescued by my mother and my aunt who came after I informed them through telephonic call about the torture and harassment meted out to me. Thereafter, at 8:31 p.m., of 08/12/2024, I was treated at JNIMS, Porompat and I am still suffering from extreme pain due to the said injuries.

My husband is a VDF personnel being posted at Reserve Line, Imphal East and most of the time he does not stay at home and while returning home he is intoxicated with alcohol. Further while he is not at home, my husband's mother, elder brother and sister-in-law used to scold me using harsh words.

Today incident is not the first time where I had been harassed and beaten by my husband and my mother-in-law. On numerous occasions, I had been assaulted and harassed by them for not giving money which I used to earned working in a private job. It would be pertinent to mention here that on 19/07/2024, I was kicked out from my home by my husband on the instigation of his family members after assaulting and harassing me. On the following day, i.e. 20/07/2024, I had filed an application to the Family Counselling Centre, Porompat, Imphal East District Police for giving an opportunity by summoning my husband for reunion with him hoping that there is chance for living as





husband and wife. In this regard, an agreement was entered between me and my husband on 22/07/2024, thereby undertaking by my husband to take responsibility for me and my future welfare and not to commit any sorts of harassment to me which he had failed to comply by assaulting and harassing me just after returning home and started neglecting me. Both my husband and my mother-in-law even started not eating food which I cooked for them.

It is therefore respectfully requested that your goodself may kindly cause the arrest of my husband, namely Sarangthem Santosh Singh, his mother-in-law, his elder brother and his elder sister-in-law and register an FIR against them for assaulting and subjecting me to cruelty as soon as possible.



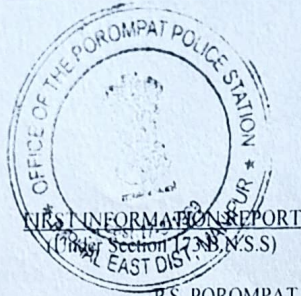
