Subject:- Request to take up necessary legal action to one namely Thangjam Borobohon aged 45 to 50 years of Kyamgei Mamang Leikai.

Sir,

With due regards I have the honour to lay down a few words that on 30th January, 2025 at around 8:30 pm at Kyamgei Mamang Leikai near Kyamgei Khagemba Macha Ibungo Temple while I was returning from "NIELIT Akampat after training session on Cyber Forensic and Digital Evidence" one person namely Thangjam Borobohon aged about 45 to 50 years from Kyamgei Maning Leikai assaulted me with iron rod without any reason. Brief of the incident is that while I was returning home on uniform from NIELIT Akampat after completion of training class on reaching at Kyamgei Mamang Leikai near Kyamgei Khagemba Macha Ibungo Temple a vehicle seems to be Mini Bus driven by one namely Thangjam Borobohon aged about 45 to 50 years from Kyamgei Mamang Leikai in front of my vehicle unusually. On that I gave horn to give a way and a signal light also given but the driver of the mini bus stop and shouted towards me by pointing his for-finger towards me. On that the driver of the mini bus came down by holding an iron rod and shouted with rubbish words and came towards me. I told him that I am a police personal returning home from duty but he further shouted as "Shakthugi police no kayam faogayneo touningba touraku" and started to pull out me from my vehicle and also drag my uniform shirt and further punch me on my face and later hit with the iron rod on my left side of the head as a result of which I fell down unconsciously. While I got conscious I was at Noor Hospital Lilong with one of my friends present there.

In facts of the above incident, I would like request to kindly take up necessary legal action to the culprit namely Thangjam Borobohon of Kiyamgei Mamang Leikai for his intention to murder me in taking the advantage of darkness and also his behaviour of disobeying police uniform by consuming alcohol and driving his vehicle as it like a gonda on the main road.
