Sub:- Report.

I have the honour to report that yesterday i.e., 08/02/2025, at around 9:00 pm, information was received that some unknown miscreants had snatched arms and ammunitions from IRB/MR personnel on duty in Kakmayai, Thoubal District and that, inputs were collected to arrest the miscreants and recover the snatched arms and ammunitions. Meanwhile, at 11:05 pm of the same day, a specific input was received from our own source that some heavily armed miscreants suspected to be armed with looted/snatched weapons from police/MR/IRB are spotted in Tellou Mayai Leikai, under Lamlai PS. The said input was informed to superior officers and with their permission, a combined team consisting of teams of Commando Imphal East district, Commando Imphal West district, Special Commando Unit, Commando Thoubal district was organized and launched operation in Tellou Mayai Leikai, under Lamlai PS in early hour of 09/02/2025 under the command of Shri Kh. Herojit Singh, MPS, Addl SP (Ops), Imphal East and Inspector Kh. Henery, OC-CDO/Imphal East comprising of Inspt. M. Uttam Singh of CDO/IE Unit assisted by Jem. Md. Amir Sultan of 1st MR/CDO/IE Unit. Two column of 8 Bihar Regiment and another two columns of 4 AR were stationed at Lamlai police station as back up and stand-by forces for utilization in any case of exigency.

A hideout of armed miscreants was identified after hectic efforts; it was cordoned by the police teams and three striking teams led by Shri Kh. Herojit Singh, MPS, Addl. SP (Ops), Imphal East, Inspector Kh. Henery Singh, OC CDO/Imphal East and Inspt. M. Uttam Singh of CDO/IE Unit raided the hideout of the armed miscreants in swift action. The hideout was a katcha structure and did not have door, and when the striking team was about to enter the structure, one miscreant was spotted without arm. He was swiftly detained and without delay, the striking team entered the two rooms and found six more miscreants armed with sophisticated weapons in the two rooms. The raiding was very professional and the team advanced so

courageously against the armed miscreants in the hideout in such a way that the miscreants were taken by surprise and overpowered six armed miscreants and one unarmed miscreant, unless there could be casualty of civilians since the hideout was located near to civil residences. The six miscreants were first disarmed and on examination, the seven miscreants identified themselves as: ; (i) **Moirangthem Somokanta Singh @ Pakpa** (26 years) S/o- (Late) **M. Mangi Singh of Moirang Thamnapokpi Kha Leikai, Moirang PS, Bishnupur District**, (ii) **Thongam Iboton Singh @ Thouyangba** (34 years) S/o- **Th. Modon of Jiribam Boroikhan, Jiribam PS, Jiribam District**, (iii) **Heisanam Rohit Meitei @ Mangangngamba** (32 years) S/o- **H. Yaima Meitei of Moirang Thamnapokpi Mamang Leikai, Moirang PS, Bishnupur District** (iv) **Yaikhom Inao Singh @ Chinglai** (20 years) S/o- **Y. Ebungcha Singh of Ngaikhong Siphai Maning Leikai, Ward No. 7, Bishnupur PS, Bishnupur District**, (v) **Nameirakpam Jotin Meitei @ Pherappa** (33 years) S/o- (Late) **N. Basanta Meitei of Langgol Laimanai Mamang Leikai, Lamphel PS, Imphal West**, (vi) **Ningthoujam Premkumar Singh @ Punsinol** (32 years) S/o- **N. Manglemba Singh of Keibul Mayai Leikai, Keibul PS, Bishnupur District** and (vii) **Hemam John Singh @ Athoiba** (33 years) S/o- (Late) **H. Sanayaima Singh of Moirangkhumou Mayai Leikai, Keibul PS, Bishnupur District**. On checking their belongings, three nos. of mobile phones, five nos. of Bullet Proof (BP) jackets and two nos. of wallet were found and recovered from their possession.

One further examination, they disclosed that they are cadres of outlawed outfit National Revolutionary Front of Manipur (NRFM) operating in Manipur under one self-styled Chairman Thangjam Dhaballo Singh @ Macha @Premananda @Naocha of Nongren Maning Leikai, Imphal East who is now suspected to be operating in Manipur from Bangladesh. Besides possession of automatic rifles, spot examination further disclosed that they are involved in many extortion activities from general public, government offices, shops etc. in different areas of Imphal, throwing bombs in houses for denial of extortion, recruitment of cadres, kidnapping, looting and also indulged in arms and ammunitions trade inside Manipur. Hence, they are arrested from the hideout/spot located some 300 meters north-east to Tellou Chana Upper Primary School in Tellou Mayai Leikai, under Lamlai Police Station, Imphal East at 12:50 am of the same day.

From the possession of the arrestee, **Moirangthem Somokanta**, one A1 assault rifle marked as 'MA-3MKII' loaded with 15 live rounds in the magazine, one wallet containing one AADHAR card and one BP jacket were seized from the spot at 1:00 a.m. by observing formalities. One INSAS Rifle marked as '18310967' loaded with 14 live rounds in the magazine and one BP jacket were seized from the possession of **Thongam Iboton @Thouyangba** from the spot at 1:10 a.m. by observing formalities. One INSAS Rifle (folding) marked as '18483746FB' loaded with 14 live rounds in the magazine, one mobile phone (Redmi 13C) bearing IMEI 865226060746760 & 865226060746778 along with one Jio SIM card bearing no. 89918650400018079311 and one BP jacket were seized from the possession of **Heisanam Rohit Meitei @ Mangangngamba** from the spot at 1:20 a.m. by observing formalities.

From the possession of the arrestee, **Yaikhom Inao @ Chinglei**, one SLR rifle marked as '16255125' loaded with 15 live rounds in the magazine and one BP jacket were seized from the spot at

30 a.m. by observing formalities. One AK 47 rifle marked as '03014' loaded with 13 live rounds in the magazine, one wallet containing one AADHAR card and one BP jacket were seized from the possession of the arrestee **Nangmeirakpam Jotin @ Pherappa** at 1:40 a.m. from the spot by observing formalities.

One SL R marked as 'CJ2374' loaded with 15 live rounds in the magazine and one mobile phone (Redmi 12 5G) bearing IMEI no. 860825054737357/78 & 860825054737365/78 along one Jio SIM card bearing no. 89918650400208515355 were seized from the possession of the arrestee **Ningthoujam Premkumar @ Punsirrol** were seized from the spot at 1:50 a.m. by observing formalities.

From the possession of the arrestee, **Hemam John @ Athoiba**, one mobile phone (Redmi 10S) bearing IMEI no. 861823057026943/35 & 861823057026950/35 along with two SIM card bearing no. Airtel - 8991160990024376859U and Jio - 89918650400125639858 were seized from the spot at 2:00 a.m. by observing formalities. However, due to existence of severe threat to police team at the spot keeping in mind the existing situation, the mandatory requirements of photography and videography could not be done at the spot during seizure and arrest.

Spot examination further disclosed that out of the six arms seized, five arms must be arms looted/snatched from Manipur police/Manipur Rifles/Indian Reserve Battalion. It is therefore the arrested cadres of NFRM and the seized arms, ammunitions and other equipments are handed over to you for further investigation and for appropriate legal action against them.
