Sub:- Report.

I have the honour to report that today i.e. 18th December, 2024 at about 1:00 p.m. received a specific information from our own intelligence about the presence of some anti-social elements at Mantripukhri Bazar, Imphal East District, threatening the general public and disturbing the normalcy of the present law and situation. Based on the said information, a combined team of CDO Imphal East Unit and HNG/PS under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and Inspt. Kh. Pathou Meitei, OC-HNG/PS under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a mobile frisking and checking to the suspected passersby at Mantripukhri Bazar, near UCO Bank, Imphal East District.

In that, one scooter (Honda Activa) was spotted driving speedily towards our frisking and checking point. On noticing their suspicious nature, our CDO personnel immediately halt the two unknown persons and detained for verification and checking. On verification, the driver of the scooter identified himself as one, **Sanjrambam Luha Meitei, aged about 29 years, S/o S. Naba Meitei of Yumnam Patlou Awang Leikai, Imphal East** and the pillion rider identified himself as one **Nongthombam Etombi Meitei, aged about 35 years, S/o N. Tomcha Meitei of Yumnam Patlou Makha Leikai, Imphal East**. On checking the driver of the scooter (Sanjrambam Luha Meitei); (i) 2 (two) nos. of Demand Letters of the outfit KCP (PWG), (ii) 16 (sixteen) nos. of Cash Receipt notes of the outfit KCP (PWG) group, (iii) 2 (two) nos. of mobile phones, (iv) One wallet containing a sum of Rs. 2200/- (two thousand two hundred rupees), two nos. of ID Cards and (v) One sling bag, black in colour were found and recovered. On checking the pillion rider (N. Etombi Meitei), one mobile phone was found and recovered from his possession.

On verification, the detainee (Sanjrambam Luha Meitei) stated that he is an active member of the outfit KCP (PWG) group, joined in the month of September, 2024 though one Mr. Dina of KCP (PWG) group and presently working under the command of one s/s - Chief of Central Finance Mr. Ningthou @ Lenin of KCP (PWG) group. The detainee further stated that on the command and advice of the said s/s - Central Finance Mr. Ningthou @ Lenin of KCP (PWG) group, he had extorted a huge amount of money from the general public, private firms, govt. offices etc. for raising their party fund. On verification, of the second detainee (N. Etombi Meitei), he stated that he joined the outfit, KCP (PWG) group though the first detainee, Sanjrambam Luha Meitei and presently working under his command. He (N. Etombi Meitei) further stated that he is also directly involved in the extortion of money from the general public for raising their party fund under the command of the first detainee, Sanjrambam Luha Meitei.

Both the detainees further stated that, today they came to Mantripukhri bazar and collected the above recovered money i.e. Rs. 2200/- (two thousand two hundred rupees) from the local shopkeepers on the command and instruction of the said /s - Chief of Central Finance Mr. Ningthou @ Lenin of KCP (PWG) group.

Based on the above facts and circumstances, both the detainees were arrested from the spot i.e. Mantripukhri Bazar near UCO Bank at 1:42 p.m. by observing due formalities. From the possession of the arrestee, Sanjrambam Luha Meitei; (i) 2 (two) nos. of Demand Letter of the outfit KCP (PWG) duly signed by one *Comrade Ningthou, Chief of Central Finance People's War Group*, (ii) 16 (sixteen) nos. of Cash Receipt notes of the outfit KCP (PWG) group, of which three Cash Receipt are duly sign by one *Comrade Ningthou, Chief of Central Finance People's War Group* and one Cash Receipt was duly sign by the first detainee, Sanjrambam Luha Meitei, as Loya, (iii) One mobile phone (Ringme) bearing IMEI no. 359912105958204 along with one Airtel SIM card bearing no. 8991106990023592372U, (iv) One mobile phone (Redmi C21) bearing IMEI no. 863541057366170/20 & 863541057366162/20 along with two SIM cards bearing no. Jio - 89918690500022882022& Airtel - 8991160990004623899U, (v) One wallet containing a sum of Rs. 2200/- (two thousand two hundred rupees), one AADHAR Card and one Voter Card, (vi) One sling bag, black in colour and (vii) One scooter (Honda Activa), blue in colour, without regd. no. bearing Engine no. JF91E-W-7061552. & Chassis no. ME4JF91ABNW061655 were seized from the spot i.e. Mantripukhri Bazar near UCCO Bank at 1:50 p.m. by observing due formalities.

One mobile phone (Realmi - C25Y) bearing IMEI no. 860701058317936/01 & 860701058317928/01 along with one Airtel SIM card bearing no. 8119960990014144415U was seized from the possession of the arrestee N. Etombi Meitei from the spot i.e. Mantripukhri Bazar near UCO Bank at 1:55 p.m. by observing due formalities.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal procedures against them.
