That, today i.e 30/01/2025 when I came back from my collage NIT Imphal after class, on reaching near Lamlongei community hall ( Maning Leikai) at about 01:30 pm, one unknown accused boy aged about 24 years wearing maroon jogging and black pant suddenly approached nearby me and started forcefully pulling my neck and strangle by right leg. Thereupon I protected myself from falling and after a new minute he ran away towards catholic retreat house without saying a word. The accused in not known to me before. His indecent act with intention to outrage my modesty who is a girl belonging to Scheduled Tribe in the middle of the road in a broad daylight is a criminal offence and is punishable under Bharatiya Nyaya Sanhita 2023 and SC/ST atrocities Act, 1989.

Hence this written complaint for registration of FIR and to punish him in accordance with the law of the land for the ends of Justice.
