**Subject : Report.**

Sir,

I have the honour to report that today i.e. the 2<sup>nd</sup> January, 2025 at about 8:00 p.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some armed miscreants were loitering in and around Kairang-Heikrumakhong areas of Imphal East District with an intent to conduct pre-judicial activities. Immediately, the information was given to senior police officers of Imphal-East District and teams of CDO Imphal East Unit led by myself under the command of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East rushed to the said area and conducted a random frisking and checking to the suspected passersby at Kairang near Heingang Chingkhong Imphal East at about 8:30 p.m.

In that, one suspicious car (Chevrolet Beat) black in colour, was spotted coming from the southern side. Immediately, our CDO team stopped the car and asked the driver to climb down from the car for checking and verification. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one **Wangmayum Sanathoi, aged about 23 years, S/o Md. Jakir Hussain of Mayang Imphal Bengoon, Imphal-West District, A/p – Hatta Golapati Care Lane, Imphal East District** an active member of the outfit UNLF (Pambei group). He stated that he joined the said organisation through one Mr. Tiger of UNLF (Pambei group) in the year 2023 and got his basic military for 45 days in the same year with allotted army no. 3198 of 55<sup>th</sup> batched at Ingourok, Manipur. He further stated that he is presently holding the rank of s/s – Private working under his command of the said Mr. Tiger of UNLF (Pambei group).

On further verification, the detainee stated that, in the months of October, 2024 he left the organization for continuing his studies further. However, he followed a path of crime and criminals and reveals that he along with some of his associates performed many pre-judicial activities like possession of illegal arms, threatening general public by possessing illegal arms, extortion, motor vehicle thief etc. He is also suspected to be involved in kidnapping, extortion, motor vehicle snatching incident that occurred in different places such as Sapermeina, Sekmai and Bishnupur. In the light of these, the detainee has been arrested from the spot i.e. Kairang near Heingang Chingkhong at 9:01 p.m. by observing due formalities. One car (Chevrolet Beat), suspected to be a stolen/snatch vehicle, bearing regd. no. MN-01W/8529, black in colour having Engine no. B12D1182391KC3 & Chassis no. MA6BF482CAT008149 along with its regd. certificate and one mobile phone (Redmi 9 Power) bearing IMEI no. 868915058716093/01 & 868915058716101/01 along with one Airtel SIM card having mobile no. +91 8798 471601 were seized from the possession of the detainee at the spot i.e. Kairang near Heingang Chingkhong at 9:10 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being hand over to you for taking up further necessary legal action against him.
