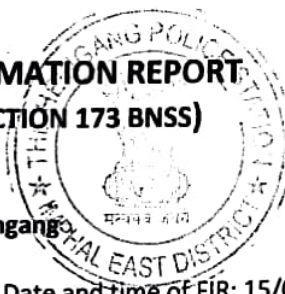

Sir,

I have the honour to report that on 14/01/2025 at around 06:45 pm, my husband namely Md. Sanwas Khan aged about 33 yrs S/o Md. Leharuddin of Kairang Mayai Leikai, HNG-PS, IE was kidnapped by some unknown persons from Kairang Tera Makhong, HNG-PS/IE.

That on the same day at around 9:57 pm, the said kidnapper called up in phone of the victim's younger sister phone no.9863428750 (as I don't used phone) through the victim (my husband) phone No. 9612192963 and demanded a sum of Rs. 5,00000/- (Rupees five lakhs) for his safe release and further direct to bring the demanded sum amount at Andro. The kidnappers made a several calls insisting to bring the said demanded amount.

Later, on 15/01/2025 at around 05:10 pm it is learnt that my husband (the victim) was brought at Thoubal District Hospital by Arambai Tengol (AT) Unit-II of Andro, where the Doctor declares brought dead.

In this regard, respected OC/HNG-PS/IE is requested to take up necessary legal action against the culprits.
