

Subject : Report.

Sir,

With due regards, I beg to state that today on 07/01/2025 at about 4.00 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Irong Tangkhul village near the river bank of Hangoi Lok for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 4 AR COB, Thoubal led by Inspl. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 5:00 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of 9mm pistol along with magazine bearing registration No. 04321, (2) 1(one) no. of Pompei gun/ improvised mortar, (3) 2(two) nos. of 36 HE hand grenade, (4) 1(one) no. of Detonator, (5) 2(two) nos. of tear smoke shell (soft nose), (6) 1(one) no. of Anti-riot Dye marker grenade, (7) 4(four) nos. of 7.62mm live rounds, (8) 5(five) nos. of 9mm live rounds, (9) 4(four) nos. of 5.56mm live rounds, (10) 1(one) no. of binocular, (11) 1(one) no. of Radio set (baofeng) along with charger, (12) 1(one) no. of Radio set (Motorola vertex standard), (13) 8(eight) nos. of 7.62mm empty case, (14) 5(five) nos. of 9mm empty case and (15) 8 (eight) nos. of .303 empty case from the spot at 5:48 am. The massive searched Operation was conducted from 05.00 am to 7:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
