Subject : Report.

Sir,

With due regards, I beg to state that today on 31/12/2024 at about 02.00 p.m. received a reliable information from 165 INF Bn. TA that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Ikop Pat for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 Assam Rifle, D/66 Bn. CRPF, Thoubal led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh. Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL rushed to the spot immediately and launched a massive operation at 03:10 p.m. On searching the undernoted articles i.e. (1) one no. of Anti Material Rifle (AMR) bearing registration 1S14923 with sight scope and one magazine, (2) two nos. of Single Bolt Action Rifle, (3) three nos. of 9mm Pistol (Country made), (4) one no. of 36 HE Hand Grenade, (5) four nos. of MK-13T, (6) ten nos. of 303 empty case ammunition, (7) two nos. of 7.62 empty case ammunition, (8) four nos. of 7.62 x 39mm empty case ammunition, (9) one no. of Stun Shell, (10) one no. of Tear Smoke Shell, (11) one no. of Tube Launching and (12) three nos. of 12 Bore Cartridge were found from the spot at 04:10 p.m. Hence the above noted articles were seized at 04:30 p.m. by observing formalities. The massive searched operation was conducted from 03:10 p.m. to 05:00 p.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
