Subject : Report.

Sir,

With due regards, I beg to state that today on 15/01/2025 at about 4.00 a.m received an input from 165 TA that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the bush of Salam Patong village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 4 AR COB, Chandrakhong (including ARL-670 ED Dog Ruby) led by Insp. K. Nitarnanjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:30 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of 9mm CMG magazine, (2) 4(four) nos. of 36 HE Hand Grenade, (3) 3(three) nos. of Radio Set marked as TYT TH-UVF80, (4) 1(one) no. of TYT TH-UVF80 Radio Set charger, (5) 2(two) nos. of TYT TH-UVF80 Radio Set adapter, (6) 3 (three) nos. of TYT TH-UVF80 Radio Set Antenna, (7) 1 (one) no. of Helican Antenna, (8) 5(five) nos. of Ni-Cad Battery, (9) 3(three) nos. of Tear Smoke Shell Soft Nose (SR), (10) 1(one) no. of Tear Smoke Shell (Chilli), (11) 1(one) no. of Arming Ring, (12) 1(one) no. of Detonator, (13) 2 (two) nos. of 7.62 x 54 mm live rounds, (14) 3 (three) nos. of 5.56 x 45 mm live rounds, (15) 19 (nineteen) nos. of 9 mm live rounds and 16) 117(one hundred seventeen) nos. of 7.62 x 39 mm empty case from the spot and seized at 5:56 am. The massive searched Operation was conducted from 04:30 am to 7:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
