Sir,

I have the honour to report that today i.e. the 21st January, 2025 at about 12:00 noon received a reliable information from 4 AR corroborated with our own intelligence about the presence of some anti-social elements were loitering in and around Mantripukhri Bazar, Imphal East District with an intent to conduct pre-judicial activities like extortion of money from the general public. Based on the said information, a combined team of CDO Imphal East Unit and HNG/PS under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and Inspt. Kh. Pathou Meitei, OC-HNG/PS under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a mobile frisking and checking to the suspected passersby at Mantripukhri Bazar, Imphal East District.

In that, one suspicious scooter (Vespa) yellow in colour, was spotted coming from the southern side. Immediately, our CDO team stopped the scooter for checking and verification. On checking the detainee body, two nos. of mobile phones and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one Pukhrambam Thoiba Singh @ Khwairakpa (38 years) S/o P. Cheitei Singh of Ngaikhong Khullen Mayai Leikai, Bishnupur District an active member of the outfit KCP (MFL group).

On further verification, the detainee stated that he joined the said organisation through one Mr. Salai of KCP (MFL) and presently working under his command. On further verification, the detainee stated that, on the advice of the Mr. Salai, he had extorted a huge amount of money from the general public, govt. officials, and shopkeepers for raising their party funds. The detainee further stated that today on the advice of the said Mr. Salai of KCP (MFL), he is on his way to collect extortion money from various shops/shopkeepers located at Mantripukhri Bazar, Imphal East.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Mantripukhri Bazar opposite to A-Cube Departmental Store, Imphal East at 12:48 p.m. and seized; (i) one scooter (Vespa, yellow in colour) without regd. no., bearing Engine no. M449M3131274 & Chassis no. MET0000AAUH071051, (ii) one mobile phone (Narzo 50A) bearing IMEI no. 86518659384496/18 & 865167059384488/18 along with two SIM cards bearing no. Jio - 89918650400014511143 & BSNL - 8991778042231019772, (iii) one mobile (Snexian Rock) bearing IMEI no. 353514714748624 and 353514714748632 along with one Airtel SIM card bearing no. 8991160990023591239U and (iv) one wallet containing a sum of Rs. 1000/- (one thousand rupees) and one AADHAR card from his possession at 12:55 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
