

I have the honour to report that today i.e 24th January, 2025 at about 03:00 am information from a reliable source about movement of some arms miscreants in general area of Awang Potsangbam Khunou foothills of Imphal East District. Based on the said information, a combined team of CDO, Imphal East District (consisting of two Gypsy teams and other officers and personnel namely Hav. 05006254 Th. Gyanizail Singh of 1st MR/CDO/IE and Hav No. 072007028 Kiran Heisnam of 7th MR/ CDO-IE Unit), 6 MR and a column of 4 AR under assisted by under the command of Inspt. Kh. Henery Singh OC CDO-IE unit and under the supervisor of Shri Kh. Herojit Singh, MPS Addl SP(Ops)Imphal East rushed in the said area and conducted a search operation in the general area of Awang Potsangbam Khunou Hill and its adjoining areas of Imphal East District from 04:30 am. During the searched operation by the combined team there found three nos. of sack bags i.e two plastic bag white in colour and one jute bag brown in colour, lying abandoned at a location foothill of Awang Potsangbam Khunou crossing of Koirengei-Leikinthabi road. On opening the sack bags there found the undernoted arms, ammunition and explosive:

- (i) One SLR Rifle B/No. "R-9822" without mag.
- (ii) One SMG Carbine B/No. "UU8295" without Mag,
- (iii) 2 Nos. 51 Motor(Country Made)
- One no. of .32 Pistol marked as "Made in USA" with Mag. (iv)
- (v) Two nos. of .32 Live ammunitions
- (vi) One 36 Hand Grenade Mark-1
- (vii) one grenade No. 82 Mark-1
- One Smoke Shell 50 MTR (viii)
- (ix) One wireless Radio Walkie-Talkies(Baofeng)
- (x) 2 Nos. of white plastic sack bag and
- (xi) One no. of jute sack bag

Accordingly, the said abandoned arms, ammunitions and explosive were seized from the foothill of Awang Potsangbam Khunou hill, Imphal East about 1 Kilometer north-east to Awang Potsangbam Khunou crossing of Koirengei-Leikinthabi road by observing due formalities at 5:22 am. Search operation was wind up at 5:50 am.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.
