Sir,

I have the honour to report that today i.e. 3rd February, 2025 at about 3:00 p.m. received a information from 4 AR corroborated with our own intelligence about the presence of some active members of the outfit KCP at Mantripukhri Bazar, Imphal East District with an intent to commit prejudicial activities like threatening the general public by way firing and hurling of grenades for extorting money. Acting on the said input, teams of CDO Imphal East Unit and Heingang Police Station led by Inspt. Kh. Henery Singh, OC-CDO/IE Unit and Inspt. Kh. Pathou Meetei, OC-HNG/PS under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a Cl. Ops. to the suspected passersby at Mantripukhri Bazar, Imphal East District.

In that, five suspected persons who came in a car (Hyundai Eon) were detained for verification and spot checking. On verification, the driver of the car identified himself as one; **Laishram Bulu Singh (27 years) S/o -- L. Loken Singh of Chana Mayai Leikai, Imphal East.** The occupant of the car identified themselves as; (i) **Lairenlakpam Thoiba Meitei @ Sanajaoba (27 years) S/o L. Ibotombi Singh of Phaknung Awang Leikai, Imphal East,** (ii) **RK. Nelson Singh (19 years) S/o RK. Ningthem Singh of Khurai Chingangbam Leikai, Porompat PS,** (iii) **Buyamayum Zabir Khan (19 years) S/o Buyamayum Tomba of Paobitek Mayai Leikai, Wangoi, Imphal West A/p -- Mantripukhri Labuk Maning Leikai, Imphal East** and (iv) **Kangujam Jebash Meitei (28 years) S/o K. Chandrajit Meitei of Phaknung Mayai Leikai, Imphal East.**

On checking their belongings, one mobile phone (Nokia) was found and recovered from the possession of the driver of the car **Laishram Bulu Singh.** One Sling bag containing a sum of Rs. 5, 700/- (five thousand seven hundred rupees) was found and recovered from the possession of the occupant of the car **Lairenlakpam Thoiba**

Meitei. One 9 mm Pistol loaded with magazine along with 11 rounds and one mobile phone (Narzo 50i) were found and recovered from the possession of RK. Nelson

Singh. Two nos. of Hand Grenades and one mobile phone (OnePlus CE2) was found and recovered from the possession of the occupant of the car (Buyamayum Zabir Khan).

On verification, the detainees stated that they are active members of the outfit KCP- (City Meitei) group and presently working under the command of one Mr. Malem of KCP (City Meitei) group. They further stated that they were indulged in extortion of money from the general public, private firms, govt. offices, etc. and directly involved in the threatening of general public by way of firing and hurling of hand grenades so the general public might be fear and give them the extortion money which they had made.

The detainees stated that, today, on the advice of the said Mr. Malem of KCP (City Meitei) group, they came to Mantripukhri bazar and extorted a sum of Rs. 5, 700/- (five thousand seven hundred rupees) from a mobile phone shop. They detainees further revealed that, they are further planning to extort money from various shopkeepers, govt. employees, contractors, businessman etc. for raising their party fund. So, the detainees were arrested from the spot i.e. Mantripukhri bazar near Thakur Bari at 3:37 p.m. by observing due formalities.

One car (Hyundai Eon), dark grey in colour, bearing registration no. AS-11LA/4330 bearing Chassis no. MALA251ALGM490392 and ENGINE No. G3HAGM445829, one mobile phone (Nokia TA1423) bearing IMEI no. 35001404057195/5 along with one Airtel SIM card bearing no. 8991160990023771661U were seized from the possession of the arrestee (Lasihram Bulu Singh) at 3:45 p.m. by observing due formalities from the spot i.e. Mantripukhri bazar near Thakur Bari.

One Sling bag containing a sum of Rs. 5, 700/- (five thousand seven hundred rupees) was seized from the possession of the arrestee Lairenlakpam Thoiba Meitei at 3: 58 p.m. by observing due formalities from the spot i.e. Mantripukhri bazaar near Thakur Bari. From the possession of the arrestee RK. Nelson Singh, one 9 mm Pistol marked as 'AUTOMATIC PISTAL MADE IN USA' along with magazine and 11 (eleven) nos. of 9 mm ammunitions and one mobile phone (Narzo 58) bearing IMEI no. 860771051395551/01 & 860771051395544/01 along with one Airtel SIM card bearing no. 8991160990021072141U were seized at 4:10 p.m. from the spot i.e. Mantripukhri bazar near Thakur Bari by observing due formalities.
