

12. First Information contents:

Received a complaint report through a west filed by Thounaojam Kamala Devi D/o Th Chamba Singh of Utlou Mayai Leikai, P.O/P.S- Nambol, Bishnupur District, Manipur stating that the functionaries of Scholar's Finance located at Kwakeithel Bazar namely (i) Shri Khwairakpam Dinesh Singh S/o- Kh. Ibungo Singh of Lamlongei Mayai Leikai, PO&PS-Lamshang, IW District, Manipur, (ii) Shri Leiphrakpam Gyanehor Singh S/o- (L). L. Haridas Singh of Moirangkhom Makha Loklaobung near Sika School, PO&PS- Imphal, IW District, Manipur, (iii) Shri Khwairakpam Samanada Singh, S/o- Kh. Sana Singh of Lamlongei Mayai Leikai PO&PS-Lamshang, IW District, Manipur and (iv) Shri Sanasam Binod Singh S/o- S. Lokendro Singh of Kongba Khunou near Standard College, IE District collected deposits from the investors by promising to give 5% per month to the depositors. On 17th February, 2020, the individual namely Thounaojam Kamala Devi, D/o- Th. Chamba Singh, Membership No. 202000020001020 of Utlou Mayai Leikai, PO&PS- Nambol, Bishnupur District, Manipur deposited a sum of Rs. 1,00,000 (rupees one lakhs) under a Deed of Agreement and at the time of deposit, the Scholar's Finance issued an agreement, money receipt and a passbook bearing ID/A.C. No. 202000010001020. In the agreement, it is mentioned that she will be a shareholder of the business and paid 5% per month as dividend from the profits of invested amounts which will be invested on the agriculture and allied works. However, after the month of December, 2020, the said financial group has failed to pay the said dividend till date.

That, further the said Schola's Finance informed her that they have a policy for giving gold and convinced her that the Financial Group will give her 30 san of gold if she deposited the required amounts. Thus, she deposited Rs. 2,43,000 (rupees two lakhs forty-three thousand) and issued a money receipt. In this connection, a passbook bearing ID/A.C. No. 2020000100010 indicating the amount issued has been issued. But the functionaries have been absconding without giving any information to the depositors.

That, the Scholar's Finance stopped functioning since December, 2020. Now she realized that the modus operandi of this financial group is nothing but Ponzi Scheme, which is a fraudulent investing scam promising high rates of return with little risk to investors. A Ponzi Scheme is a fraudulent investing scam which generates returns for earlier investors with money taken from later investors. The BUDS Act, 2019 was enacted by the Parliament and the same has been enforced since 21st February, 2019. Further, the Govt. of Manipur has framed the rules under the said Act and the same has been notified in the gazette of Manipur on 1st February, 2021.

That, the complainant was aggrieved by suffering an unprecedented crisis of emotional, psychological and physical breakdown in her lives due to the failure of Scholar's Finance to repay their deposited amount of money since December 2020. Further, she along with their family members and relatives had become debt ridden for the last one and half years thereby resulting to hardship of livelihood and other predicaments. In this regard, on 23rd, 2021, an agreement was made between the above-named office bearers/functionaries and some representatives of the depositors in the presence of parents/family members of the said office bearers stating that the said finance group will be opened and functioned from 2rd march, 2021 and they assured that their entitled money will be paid from the month of April, 2021 but no satisfactory action has been taken up till date. Besides, the above-named office bearers ran away and thereafter they could not meet them.
