Sir,

I have the honour to report that today i.e. 28/10/2024 at 11:50 AM, received a specific information from our reliable sources that some valley based unlawful organisation members loitering in and around Keishampat to Kwakeithel bazar areas for their prejudicial activities like giving demand letters to businessmen, Govt. Employees, hurling of hand grenade etc. Acting on this information, a team of Imphal P.S under the command of OC/IPS and overall supervision of Superintendent of Police/IW rushed at Top Leirak Machin along Imphal Airport Road and started frisking and checking those passerby and pedestrians. In that, one suspected man was detained for verification for his suspicious manner. On spot verification, he identified himself as Moirangthem Maniton Singh @ 29 yrs S/o. M. Gulamani Singh of Top Mayai Leikai, P.O & P.S - Porompat, Imphal East dist. Manipur and he was brought to Imphal PS for further verification. On minute verification, he disclosed that he is an active member of the banned outfit PLA Organization and also involved in prejudicial activities like extortion of money from the general public for fund raise. Then he further disclosed that in today's morning he demanded a huge amount of money to 4 (four) numbers of bakery located at Keishampat area to raise fund of the banned outfit PLA Organization. Later, he was arrested at Imphal Police Station by observing formalities at 12.10 PM and also seized one mobile phone Redmi-9 along with 2 (two) Sim card (9366354660 and 8118928037) on production by himself at 12.21 PM by observing formalities.

It is therefore handed over the accused person and seized items for further necessary legal action.


