Sir,

I am to report that, today i.e. 8/10/2024 at about 10:30 am while my family along with my husband Md. Tajuddin and my daughter Aiza (Age 2 years) were coming in our Astar white in colour bearing Registration No. MNo6LB5731 from our home Keirao Menjor Ingkhol towards Kongba, they were stopped by three unknown youths at Lairenpat near coffee cafe. My husband stopped the car not knowing the reason. However one among them took the key of the car and asked us to sit at the back of the car but we hesitated and protest slightly. In that they forced us by showing small arms and we were blind folded. One among them drives our car and one black colour car without registration number of the miscreants is also riding in the front. The mobile phones of my husband and mine were snatched by the miscreants. We were taken towards Khongman Mangjil road via Singjamei Bridge. I and my daughter were released at Liwa road, Langthabal side by handing over my phone. They took away my husband and also our car. I was warned not to inform the Police and any other organization otherwise my husband will be killed. I came back with my daughter by hiring an auto rickshaw. The mobile phone no. of her husband is 7085983028. The abductors has instantly demanding a huge amount as ransom for release of my husband by calling through one unknown number +1(917)563-6227 in true caller as Johnson. They demanded minimum of Rs. 20000000/- for his release frequently to my brother-in-law's phone. We are in dilemma and we don't have such huge amount to pay to the abductors for his release.

It is reported to kindly arrest the miscreants and rescue my husband and our car.
