Subject: Report on Circulation of false appointment order forging my signature-thereof.

Sir,

It has come to my notice on the 08<sup>th</sup> October, 2024, that an order giving appointment to 7 persons on contractual basis under General Administration Department bearing Order No. ESTT-301/9/2024-GAD-GAD dated 26<sup>th</sup> August, 2024 was circulated by forging my signature.

Background : On reaching office on 8<sup>th</sup> October, 2024 morning, Shri Jugin Singh (GD IV of GAD Store) showed me an order on his phone enquiring about an order signed under my name. I was shocked to see the gifted order and asked Shri Jugin Singh from where he got the order and to forward to me.

Upon enquiry, I was informed that one person by name, Puthem Mekola Singh (Mekola) included in the gifted order at Sl. No. 6 is a relative of Shri Jugin Singh and that was how he got the order to enquire about the joining date of the candidates. I immediately told Shri Jugin to bring the relative (Mekola) to my office. Around 3 PM Shri Jugin came to my office with Mekola and one other. When I asked Mekola if he knew the other people in the gifted order, he said that all persons in the order are unknown to him. Further, he himself (Mekola) is not presently attached to any office/officer. Shri Mekola also stated that he got the order from one person named 'Boi' and also mentioned the name of Hidam Shikha (# 7005710746). The other person accompanying Mekola called Hidam Shikha on the phone in my presence to enquire who gave the said order to him. On the phone, Hidam Shikha mentioned one person Rajesh Salam (# 8730919965) and informed to meet him saying that this Rajesh Salam runs a sort of clinic at Salam area.

It was discovered from them that, Mekola along with some other people in the gifted order were asked to arrange money for the said job. The matter seems to be an agenda to dupe and deceive innocent people by asking huge sums of money on false promise of giving them job by forging signature. Not only that, it has tarnished the image of a premier office Department (GAD) of the State. The name mentioned in the order was wrongly spelt and under the time period of the order, the undersigned was on Earned Leave.

A copy of the order is enclosed for kind examination. I request you Sir to kindly take up the matter in the most stringent term to investigate and identify and apprehend the culprit and prosecute for forgery, tarnishing image of a Premier Department, deceiving innocent people and related crimes for ends of justice.


