Sir,

I have the honour to state that today i.e. 10/10/2024 at about 03:00 am, a reliable information was received from our own sources about the presence of some active cadres of KCP (PWG) organisation in and around Kyamgei Maning Leikai area, Imphal East District with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Sub. Ch. Surjit Kumar of CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Kyamgei Maning Leikai, Imphal East District. During search at the house of Mayanglambam Nobin located at Kyamgei Maning Leikai, one unknown person was found in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking. During spot verification, he identified himself as Mayanglambam Dhanbir (39 yrs) @ Dhanabir @ Awangba @ Lanchenba S/o. (L) Mayanglambam Nobin of Kyamgei Maning Leikai, Imphal East District. On spot body search, one Redmi A2 mobile handset along with one Jio SIM card bearing mobile number 9366168079 and one Aadhaar card were recovered from his possession.

During preliminary verification, he disclosed that he is an active cadre of KCP(PWG) organisation and he join the said organisation in the year 1997 and was allotted army no. 0316 of 1997 and he is presently working under the command of one s/s Commander Mayongba of KCP(PWG) organisation who is presently staying at Kangchup area and under the instruction of his commander, he along with his associate namely one Chingkhel served monetary demands to various shops and general public residing in and around Imphal area and they handed over the extorted money to their commander for their party fund.

Hence, he was arrested from the spot at 04:40 am and the above recovered articles were seized from the spot at 04:42 am by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against him.
