Sir

I have the honour to report that today i.e. 10/10/2024, at about 8:00 am while I was staying at home, one boy of our locality brought 2(two) envelopes and handed over to me. When I opened the envelopes, I found two demand letters of KCP (Kangleipak Communist Party (MC) Nongdrenkhomba) Department of Finance. In the demand letters, a donation of 5(five) lakhs each against me and my elder brother namely Hefa were written. The boy narrated that the two unknown youths came riding in a Motor bike (bullet) and stopped at Kiyamgei Takhok Makha and told to hand over the envelopes to me. In the demand letters it is written that "Yawol ehon ashida KCP (Nongdrenkhomba) na maning tamba manaba khunnai ama semduna awonba ama puraknaba hotnabada eikhoina hanba leitana hotnakhigani, adubu maning tamba kangleipak ama oihannaba hotnabada meeyam gi mateng yaodana oithokloi, maram ashina Yawol ehon asi khumang chaosinbagidamak adomgi mamal yamlaba mateng nijari".

The demand letters along with this report are being handed over to you for taking up necessary legal steps.
