12. First Information contents:

Today i.e. 16/11/2024 at 4.50 pm, received information that on the same day at around 4.40 pm, a huge irate mob numbering about 400/500 persons including men and women holding deadly weapons like daw, stick, iron rod, catapult etc. stormed at the residence of Shri Khwairakpam Raghumani Singh, Hon'ble MLA, Uripok-AC r/o Uripok Kabrabam Leikai, Imphal West by violating the prohibitory order of the DM-IW dtd. 16/11/2024 u/s 163 of BNSS as a protest against the kidnapping and killing of some individuals including women and children by suspected Kuki militants at Jiribam District. The violent mob also attacked and intimidate the family members of the Hon'ble MLA and vandalized the security structures and household properties of the Hon'ble MLA thereby causing significant damage to the household properties. Further, the members of the irate mob have burnt down the materials of the security structures and household properties.

Hence, a suo-mottu case under FIR No. 561(11)2024 IPS u/s 191(3)/223/109(1)/351(2)/324(4)/326(g)/3(5) BNS has been registered for investigation.
